Zeke was born in Birmingham, Alabama, the only child of John Leonard Zettner and Emma Miller Zettner. After high school graduation, Zeke Joined the United States Navy, at the age of 17.

Zeke served aboard the USS Lyman K. Swenson, a 2200-ton destroyer. He was deployed to the Far East, where he was engaged in vigorous combat activities, including the Inchon Invasion on September 15, 1950, in South Korea.

Shortley after the Invasion, the six destroyers involved were designated as the "Sitting Ducks" because they did not leave their assigned positions for three days prior to the Invasion, sitting there shooting it out with the enemy. The USS Lyman K. Swenson salled home later, proudly flying the "Sitting Ducks" pennant.

Zeke was proud of his 22-year Naval career, which began in 1944 and ended in 1966, when he retired as a Chief Petty Officer (CPO E-7). Zeke was married to Delores Watson Zettner (now deceased). They had three children, Bill, Adriene, and John, Jr., all of whom live in the San Diego area. After Zeke's retirement from the Navy, he worked in the floor covering business with his two sons. His daughter, Adriene, has held top-management positions with the Von's grocery company for thirty-one years. Adriene is like her father, always willing to help whenever and wherever she is needed. I am truly grateful to have her as a close friend.

Zeke and I met thirty years ago, in 1978. We were married on March 17, 1990, in the romantic "Fern Grotto" on the beautiful Island of Kauali. We vacationed in Hawaii many times, and the Joy and love we shared during those days will be with me forever.

We enjoyed attending the annual reunions with Zeke's fellow shipmates. The group always met in a different city, so we had a chance to visit new and interesting places together. We would look forward to the event for months before we left, and then reminisce and look at our pictures for months after we returned.

Zeke was my loving husband, but just as important, he was my best friend. He helped me in every way possible, always making sure I was all right.

Playing Santa Claus for the children of the families where I work was such fun, and was so Zeke!
